## **REACH Policy Statement:-**

In accordance with the following directive:-Regulation No UK SI 2020/1577 Regulation No EC 1907/2006 REACH

Avantek Ltd is an ISO 9001:2015 certified company and applies quality management principles across all *operations* and is fully committed to minimising our impact on the environment through environmentally sound business practices. In addition, we ensure our products comply with applicable chemical regulations including UK and EU REACH.

In response to consumers inquiries regarding the UK REACH Regulation (SI 2020/1577) and EU Regulation No 1907/2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH), we hereby declare that:

- 1. We have classified that products we are supplying:
  Bars, billets, plates, sheets, forgings, rings, tubes in alloys Ti6AL4V; Ti6AL4V ELI;
  Ti10V2Fe3AL; Ti15V3AL3Cr3Sn; Ti6AL2Sn4Zr2Mo; Ti6AL2Sn4Zr6Mo; Ti2AL2Sn2Zn2Mo2Cr;
  Ti6AL7Nb, Ti6AL6V2Sn; Ti3AL2,5V; Ti8AL1Mo1V; Ti4AL4Mo2Sn; Ti5AL5V5Mo3Cr;
  Ti5AL4Mo1Cr; Ti6AL4Zr1Mo1Sn; Ti4AL3Mo1V are considered as articles and based on Article 7 of Regulation (EC) No 1907/2006 the substances in our products do not need to be registered under REACH requirements.
- **2.** The articles do not contain any such declarable substances, which meet the criteria in Article 57 and are identified in accordance with Article 59.
- **3.** We confirm that our products do not contain any of the substances from REACH Candidate List of Very High Concern (SVHC) and Aerospace and Defense Declarable Substances List (AD-DSL).
- **4.** Should any future updates identify SVHCs above the relevant threshold in our products, we will notify customers in accordance with Article 33 obligations.

This REACH statement has been developed to assist our customers in their due diligence responsibilities.

We confirm that we have contacted our supply chain and have received assurances that there is no indication that any products supplied by Avantek Ltd will contain any of the restricted substances or substances of very high concern.

We will monitor legislation and ensure that our suppliers and our products continue to be compliant with all future requirements and amendments and will inform all required parties should there be any change to this statement (as required by Article 33).
